FILLING AND FENCING OF ABANDONED /OLD MINES

Sindh Lakhra Coal Mining Company (SLCMC), a Public Sector Company under the administrative control of the Energy Department, Government of Sindh, invites sealed proposals from recognized and eligible companies/firms/contractors registered with Federal Board of Revenue (FBR), Sindh Revenue Board (SRB) and possessing at least two years of relevant experience (documentary proof required).

SLCMC intends to fill/fence permanently closed shafts and mines to ensure the safety of surrounding communities, livestock, and the environment. Approximately 70 abandoned vertical shafts are included in the scope of work — comprising filling, compacting, fencing, and site restoration.

The interested companies having sufficient, machinery, experience and capacity for above mentioned work may participate under this proposal with the following terms & conditions.
